Newly revised Whereabouts Policy and Anti-Doping Rules of Hong Kong Anti-Doping Committee

I write to inform you that the Whereabouts Policy and Anti-Doping Rules of Hong Kong Anti-Doping Committee (HKADC) have been revised and will take effect on 1 April 2018.

HKADC Whereabouts Policy

The structure of HKADC's Testing Pools and their inclusion criteria have been revised. Former "Testing Pool A and B" are now renamed as the "**Registered Testing Pool (RTP)**" and the "**Elite Testing Pool (ETP)**" respectively with newly defined inclusion criteria. Anti-Doping Rules of HKADC
