#### 1. Scope of Works

- Providing, installing 20 feet containers
- · Relocating and cleaning the existing containers
- Disposal of old containers
- · Design, provide and install corrugated steel roofing sheets canopy for containers
- Providing concrete footing, ramps and means of fixing

### 2. Terms and Conditions

- 2.1 The materials and workmanship for the works shall follow the attached Specifications. In case of doubt or discrepancy, the Project Manager shall be notified as soon as possible for necessary clarification.
- 2.2 Apart from the Form of Tender, the Contractor should also complete and submit the Schedule or Rate with the tender. The tendered sum shall be deemed to include all costs associated with all the works, such as provision of temporary electricity and water, overheads, insurances, supervision, safety precautions and other expenses as well as the contract preliminaries. The tenderer should submit the company profile, job reference management organization chart, (financial report) legal case if applicable together with the tender
- 2.3 The Contractor is advised to visit the Site and make himself thoroughly acquainted with the location, general site conditions, accessibility, restrictions for loading and

- off-loading plants etc., and any other conditions which may affect pricing. No claims for extra payment or extension of time for completion will be allowed on the grounds of ignorance of the conditions under which the Works are to be carried out.
- 2.4 The contracted work shall be completed within 15 days, from 1 March 2019 to 15 March 2019 or the Employer reserves the right of claiming liquidated damages.
- 2.5 Any defects, excessive shrinkage or other faults, which appear within <u>5 years</u> of the date of completion certified by the Project manager and which are due to materials or workmanship not in accordance with the Contract, shall be made good by the Contractor within a reasonable time entirely at his own cost, unless otherwise instructed by the Project manager. Project manager shall certify the date when, in his opinion, the Contractor's obligations under this clause have been fulfilled.
- 2.6 The tender shall be a lump sum fixed price tender for carrying out of the whole works in conformity with the Specifications. The quantities of work as stated in Schedule of Rate were for reference only, and; not from part of contract.
- 2.7 Expect where specifically stated to the contrary, all price entered in the tender shall be at the risk of the Contractor. The tenderer should measure such works before submit tender according to site condition. No adjustment allowed at the settlement of Final Account.
- 2.8 The employer may not accept the lowest tender, and; have the right to select proper tenderer to carry out the works.
- 2.9 The Project manager may issue instructions regarding the alternation of the design quality or quantity of the Works and he may confirm in writing any variation made by the Contractor.

### 3. Insurance

- 3.1 The Contractor is required to effect and maintain appropriate insurance for the Works
- 3.2 The contractor shall provide all insurance document to the employer before the site works
- 3.3 The Contractor is also required to insure for and shall indemnify the Employer against claims or proceeding arising in respect of injury to property or injury to or the death of persons in the course of carrying out the Works.


