**Enhancement of dissemination of anti-doping information  
to athlete support personnel**

I am writing to seek your assistance in helping us to enhance the dissemination of anti-doping information to the athlete support personnel of your Association.

Since the launch of the anti-doping programme by the Hong Kong Anti-Doping Committee (HKADC), much of the anti-doping information has only been directed to individual athletes included in the Registered Testing Pool. We believe that it is the right time to include the athlete support personnel, who work closely with the athletes, in our anti-doping education/information programme.

In fact, one of the roles and responsibilities of athlete support personnel as stated in the World Anti-Doping Code is to be knowledgeable of and comply with all anti-doping policies and rules which are applicable to them or the athletes whom they support.

In view of the need to further enhance the anti-doping knowledge of all athlete support personnel, we are proposing to invite coaches, team officials, and other supporting personnel from the member associations to be included in the HKADC Mailing List.
