Applications for the World Archery International Judge Candidate status:

The applicants must possess the requirements listed in art. 7.1 App. 4 (Book 1 (C&R). In particular, they must be accredited as Continental Judges and have been accredited as National Judges for at least 3 years, must have an adequate knowledge of English and must have served at least once in a World Ranking Tournament (or a major tournament sanctioned by their Continental Association) with positive evaluation of the chairperson of the judge commission.

Application must be submitted to World Archery Office according to art. 7.2 App. 4 Book 1 (C&R): the application (signed by the applicant (the judge), his/her MA and his/her CA) must indicate the personal information of the applicant (name, gender, birth date, nationality), languages spoken, when appointed NJ and CJ, experience at WRT (or equivalent) level.

The application has to be signed by your national and Continental federation otherwise you will not be able to pass the final exam in order to obtain the WA International Judge Candidate.

The participants passing the final examination will obtain the status of "World Archery International Judge Candidate".

The participants must bring with them World Archery C&R Book and World Archery Judge Guide Book – both available from the World Archery webpage www.worldarchery.org – and a magnifying glass.

For your information, there will be a limited number of participants, so MAs registering for more than one participant, must make a priority.
